### RESOLUTIONS CONCERNING JUSTICE, HUMAN CONCERNS, AND DEMOCRACY

- 2 21-JHD-01: REFORM OF EXCESSIVE USE OF POLICE FORCE (99 WORDS)
- 3 WHEREAS, on August 23rd, 2020 a Kenosha Police Officer shot Jacob Blake in the back seven times in front of his
- 4 children;
- 5 WHEREAS, the shooting was a display of an abuse of power that is consistent within Wisconsin police departments
- 6 during interactions with people of color;
- WHEREAS, citizens have a responsibility to stand up in peaceful protest against racism and police brutality;
- 8 THEREFORE, RESOLVED, the DPW calls for statewide reform to address the excessive use of force by police
- 9 departments and for the Kenosha police officers involved in paralyzing Jacob Blake to be brought to justice and held
- 10 accountable.

#### 21-JHD-02: REQUIRING LAW ENFORCEMENT OFFICERS TO WEAR BODY CAMERAS (72 WORDS)

- 13 WHEREAS, there were 1,021 fatal shootings involving law enforcement in 2020 nationwide;
- WHEREAS, only five states have passed laws requiring officers to wear some form of recording device while on duty;
- 15 and,
- 16 WHEREAS, worn body cameras increase accountability among law enforcement and decreases abuses on duty;
- 17 THEREFORE, RESOLVED, that the DPW urge the state legislature to pass measures requiring that some form of
- recording device be used by all officers on duty.

#### 21-JHD-03: Prohibition Of Guns In The State Capitol And Other Public Spaces (91 words)

- 21 WHEREAS, in multiple states, armed terrorist groups raided capitols to intimidate or harm lawmakers;
- WHEREAS, the state capitol, as well as the working premises for public officials, are regularly visited by children or
- 23 individuals with stress-related illnesses; and,
- WHEREAS, the presence of firearms is intimidating and does not promote free and open debate;
- 25 THEREFORE, RESOLVED, the DPW calls on legislators to work in the interest of safety and civility in banning the
- presence of weapons in the state capitol and the working premises of public officials, except where required by
- 27 occupation.

#### 21-JHD-04: ENACT RED FLAG LAWS FOR COMMON SENSE GUN REFORM (85 WORDS)

- 30 WHEREAS, 600 Wisconsinites died from firearm-involved suicides and homicides in 2019;
- 31 WHEREAS, it is crucial for the safety of our citizens that common sense gun reform measures be enacted to curb
- 32 firearm deaths; and,
- 33 WHEREAS. Red Flag Laws would empower law enforcement officials and families to petition state courts to remove
- 34 all firearms from the possession of individuals whose psychological condition render them dangers to themselves
- and/or members of the community;
- 36 THEREFORE, RESOLVED, that the DPW urge the state legislature to enact Red Flag Laws.

# 38 **21-JDH-05: Enact Common Sense Gun Regulation (70 words)**

- 39 WHEREAS, Americans have witnessed mass shootings across the nation; and,
- 40 WHEREAS, some pro-qun organizations oppose reasonable legislation to protect citizens from being killed by civilian
- 41 owned high-powered weapons;
- 42 THEREFORE, RESOLVED, the DPW supports legislation restoring the ban on assault rifles and high-capacity
- magazines that expired in 2004; requiring background checks for all gun purchases and ownership transfers; and
- requiring that all stolen and lost guns be reported to the police.

#### 21-JHD-06: RESTORING VOTING RIGHTS FOR PEOPLE ON PROBATION AND PAROLE (74 WORDS)

- 2 WHEREAS, the right to vote is fundamental to our nation's democracy and should be guaranteed to every citizen;
- 3 WHEREAS, Wisconsin currently has ~68,000 formerly incarcerated people on probation/parole who are denied the
- 4 right to vote;
- 5 WHEREAS, Wisconsin has tremendous racial disparities in incarceration rates; and,
- 6 WHEREAS, preventing formerly incarcerated people from voting contributes to the racial divide polarizing our
- 7 country;
- 8 THEREFORE, RESOLVED, that voting rights be restored to felons immediately upon release from incarceration.

### 10 21-JHD-07: RESOLUTION ABOUT EQUAL ACCESS TO VOTING (98 WORDS)

- 11 WHEREAS, the fundamental right to vote and bans on racial discrimination is delineated in U.S. Constitutional
- 12 Amendments 14 and 15, and subsequent Voting Rights Acts in 1965 and 2002;
- 13 WHEREAS, voter suppression has still ensued taking the form of insufficient numbers of polling places, voter purges,
- requiring particular ID's, and restricting of early voting and absentee ballots; and,
- WHEREAS, a pandemic created a health risk to voters at crowded polling places;
- 16 THEREFORE, RESOLVED, that the DPW supports equal ballot access by preventing voter purges, requiring sufficient
- 17 numbers of polling places, continued access to early voting, and absentee ballots.

#### 21-JHD-08: RESOLUTION IN SUPPORT OF NON-PARTISAN REDISTRICTING (75 WORDS)

- WHEREAS, gerrymandering allows politicians to choose their constituents rather than voters choosing their
- 21 representatives;
- WHEREAS, gerrymandering suppresses voter turnout in non-competitive districts;
- WHEREAS, gerrymandering encourages hyper-partisanship;
- 24 WHEREAS, gerrymandering has stronger negative impacts on Black, Indigenous, and other communities of color;
- 25 and,
- 26 WHEREAS, gerrymandering perpetuates minority rule, defying the will of the people;
- 27 THEREFORE, RESOLVED, that the DPW supports an impartial, non-partisan redistricting process for all elected state
- and federal offices in the State of Wisconsin.

#### 21-JHD-09: FAIR MAPS FOR ALL (55 WORDS)

- 31 WHEREAS, gerrymandering has been detrimental to Wisconsin voters; and,
- WHEREAS, the DPW supports equal value for all votes;
- 33 THEREFORE, RESOLVED, that the members of the DPW direct the members of the Democratic Legislative Caucus to
- 34 continue to press for passage of legislation requiring a non-partisan redistricting process in the legislative session of
- 35 2021 and 2022.

#### 21-JHD-10: CENSUS DATA AND ORDER OF REDISTRICTING PROCESS (100 WORDS)

- WHEREAS, census data is required in a timely fashion for completion of redistricting;
- 39 WHEREAS, the redistricting order was reversed in 2011, ignoring municipal and county district lines, causing added
- 40 expense and confusion;
- 41 WHEREAS, Republicans seek to delay release of Census data to cities and counties;
- 42 WHEREAS, the DPW recognizes the importance of municipal and county lines;
- 43 THEREFORE, RESOLVED, DPW asks members of the Democratic Legislative Caucus to support efforts requiring
- 44 release of Census data to cities and counties between June and July 2021; and,
- 45 FINALLY RESOLVED, develop legislation requiring adherence to municipal and county district lines during Wisconsin's
- 46 redistricting process.

#### 21-JHD-11: RESOLUTION IN SUPPORT OF AUTOMATIC VOTER REGISTRATION (86 WORDS)

- 3 WHEREAS, voting is the cornerstone of our democracy;
- 4 WHEREAS, voting should be as accessible as possible to all eligible voters;
- 5 WHEREAS, nineteen states and the District of Columbia have adopted some form of Automatic Voter Registration
- 6 (AVR) as of February 2021;
- WHEREAS, under AVR, all eligible voters would be "opted in" unless they decide to "opt out," thereby making the
- 8 registration process more efficient and accessible; and,
- 9 WHEREAS, AVR would drastically increase the number of registered voters;
- 10 THEREFORE, RESOLVED, that Wisconsin should adopt Automatic Voter Registration.

# 12 **21-JHD-12: DACA (64 words)**

- WHEREAS, DACA recipients were brought to the US by parents before their age of consent;
- 14 WHEREAS, DACA recipients make substantial contributions to the economy and culture of US;
- WHEREAS, DACA recipients are among our best and brightest; and,
- WHEREAS, DACA recipients deserve protection from deportation and a path to citizenship;
- 17 THEREFORE, RESOLVED, that DPW supports a re-issue of DACA and a path to citizenship.

# 21-JHD-13: REUNITING FAMILIES SEPARATED AT THE BORDER (60 WORDS)

- WHEREAS, the U.S. separated nearly 5000 children from their parents;
- 21 WHEREAS, separating children from their family is inhumane;
- WHEREAS, children are suffering extreme psychological distress;
- WHEREAS, the government did no universal tracking of the children they took; and,
- 24 WHEREAS, we owe the families reparations for our inhumane treatment;
- 25 THEREFORE, RESOLVED, that the DPW supports all efforts to reunite separated families.

#### 21-JDH-14: Counteracting The Harm Of Citizens United (92 words)

- WHEREAS, the Citizens United decision has weakened the faith of Americans in the electoral process;
- WHEREAS, corporate donations to secretive Super PACs have led to corruption or at least the appearance of
- 30 corruption;
- 31 WHEREAS, various non-profit organizations have formed to disguise spending on political campaigns; and,
- WHEREAS, the entire base of American political life hinges on faith in the vote;
- 33 THEREFORE, RESOLVED, the DPW supports campaign finance reform that will reduce corporate influence, increase
- 34 required disclosure of corporate donations to Super PACs and similar organizations, and move to public funding of
- 35 campaigns.

#### 21-JDH-15: Universal Healthcare (96 words)

- 38 WHEREAS, people residing in the US deserve quality and affordable healthcare regardless of occupation, zip code,
- 39 religion, income, age, gender, citizenship or sexuality;
- 40 WHEREAS, quality healthcare should be a human right, not a highly commoditized service, causing financial
- 41 instability for many people;
- WHEREAS, the United States of America is the only industrialized country in the world without universal healthcare;
- 43 and,
- WHEREAS, we as a people value life and dignity for all;

- THEREFORE, RESOLVED, the DPW demands that the United States of America establish a system of universal
- 2 healthcare with the 2021 national budget and accompanying legislation.

#### 21-JHD-16: LEGALIZE CANNABIS (54 WORDS)

- 5 WHEREAS, numerous states have legalized cannabis for industrial, medical, or recreational use; and,
- WHEREAS, the legalization of cannabis contributes to the economy, health, welfare, and civil rights of the citizens of these states;
- 8 THEREFORE, RESOLVED, that the DPW supports legislation legalizing the production, sale, and use of cannabis for
- 9 industrial, medical, and recreational use.

10

### 21-JHD-17: HIGH SPEED INTERNET ACCESS (85 WORDS)

- 12 WHEREAS, there are many areas that have unaffordable or inadequate high-speed internet, or do not have access at
- 13 all;
- 14 WHEREAS, there are some communities where students have to travel to do their homework in parking lots just to
- 15 get access to Wi-Fi; and,
- WHEREAS, access to high-speed internet is a critical economic issue for small businesses and industry as well as an
- 17 educational need;
- 18 THEREFORE, RESOLVED, that the DPW supports expansion of broadband so that everyone has access to high-speed
- and an affordable internet connection.

# 21-JHD-18: Urge Candidates Running For Federal, State, And Local Office To Focus On Disability Issues (84 words)

- WHEREAS, disability issues are rarely discussed when candidates run for office; and,
- WHEREAS, disabled individuals bring a unique view to the table on topics such as transportation, health, voter
- 25 mobilization, economics, criminal justice, housing, and education;
- THEREFORE, RESOLVED, we encourage qualified applicants with disabilities to apply for staffing jobs in offices of
- 27 elected officials;
- FURTHER RESOLVED, we encourage people with disabilities to run for office; and,
- 29 FINALLY RESOLVED, that the DPW will urge our candidates to speak publicly on disability issues during their
- 30 campaigns.

#### 21-JHD-19: RESOLUTION IN SUPPORT OF LGBTQ+ EQUALITY (96 WORDS)

- WHEREAS, the State of Wisconsin has a diverse Lesbian, Gay, Bisexual, Transgender, and Queer or Questioning
- 34 (LGBTO+) community that contributes to the well-being of the State and its citizens;
- 35 WHEREAS, Wisconsin statutes do not reference gender identity;
- 36 WHEREAS, the State of Wisconsin lacks statewide protections based on gender identity in antidiscrimination laws;
- WHEREAS, the American Psychological Association reports harm from conversion therapy; and,
- WHEREAS, conversion therapy is not banned statewide;
- 39 THEREFORE, RESOLVED, DPW supports expanding discrimination protections to include gender identity; and,
- 40 FURTHER RESOLVED, that DPW supports banning conversion therapy for all citizens, regardless of age.

#### 42 21-JHD-20: OPEN GOVERNMENT - THE LIGHT OF DAY (96 WORDS)

- WHEREAS, legislators are elected by the voters;
- WHEREAS, voters need transparent voting records to make informed choices;
- WHEREAS, government has turned into a body of smoke and mirrors;

- 1 WHEREAS, voice votes are virtually anonymous;
- 2 WHEREAS, legislative work done in the middle of the night excludes most of the public and even legislators; and,
- 3 WHEREAS, legislative sessions are recessed with no regard for incomplete work;
- 4 THEREFORE, RESOLVED, that state and federal legislative bodies only vote by roll-call or electronic tally during
- 5 reasonable working hours that allow public input, and that sessions last until the work is done.

#### 21-JHD-21: Bring It To A Vote (93 words)

- 8 WHEREAS, the current system of passing legislation is controlled by four individuals in the State and Federal
- 9 chambers:
- 10 WHEREAS, every reasonable bill deserves a fair hearing;
- 11 WHEREAS, bills clearing a committee or legislative branch should get a vote for passage; and,
- 12 WHEREAS, leaders of each branch oversee the legislative process and are given the power to kill legislation
- 13 unilaterally;
- 14 THEREFORE, RESOLVED, that majority party leaders in each branch be responsible for making a schedule and
- holding a full chamber roll call vote on every piece of legislation that clears another chamber or committee.

#### 21-JHD-22: Indigenous Sovereignty (92 words)

- WHEREAS, Wisconsin is home to the Ho-Chunk Nation, Menominee Tribe of Wisconsin, Oneida Nation, Forest County
- 19 Potawatomi, Bad River Band, Lac Courte Oreilles Band, Lac du Flambeau Band, and Red Cliff Band of Lake Superior
- 20 Chippewa, St. Croix Chippewa, Sokaogon Chippewa (Mole Lake), Stockbridge-Munsee, and Brothertown Nation; and,
- 21 WHEREAS, treaties between sovereign tribal governments and federal, state, and local governments have historically
- 22 not been honored, which has disrupted the cultural connection between tribes and their land;
- 23 THEREFORE, RESOLVED, DPW acknowledges and respects tribal sovereignty, and commits to protect Indigenous
- 24 land and resources.

#### 21-JHD-23: SAFE, AFFORDABLE HOUSING (92 WORDS)

- WHEREAS, safe, affordable housing is a human right;
- WHEREAS, housing instability creates significant obstacles to accessing opportunities such as employment,
- 29 healthcare, education, and civil rights;
- 30 WHEREAS, affordable housing stock shortages have created an inaccessible housing market for many Wisconsinites
- and unsafe overcrowding during the pandemic; and,
- 32 WHEREAS, eviction law unfairly disadvantages tenants, and an eviction on one's record hinders the ability to secure
- 33 future housing;
- 34 THEREFORE, RESOLVED, DPW supports legislation and funding to improve housing quality through code
- and improve access to legal representation for tenants.

#### 37 **21-JHD-24: DATA RIGHTS (81 WORDS)**

- 38 WHEREAS, the human right to privacy includes data rights;
- 39 WHEREAS, the values of American democracy enshrine a life free from surveillance;
- 40 WHEREAS, our personal data reflects vital and sensitive information about our lives and its misuse can be
- 41 discriminatory and potentially life-threatening; and,
- WHEREAS, our data is our private property and should not be bought or sold without our express permission;
- 43 THEREFORE, RESOLVED, DPW supports broad protections on personal, biometric, and medical data from
- 44 unauthorized and unethical government or corporate use.

#### 1 21-JHD-25: RESPONDING TO MAY 25TH ANNOUNCEMENT OF CENSUS BUREAU REFUSAL TO RELEASE RAW ERROR

- 2 CALCULATIONS: RELEASE ACCURATE CENSUS DATA (100 WORDS)
- 3 WHEREAS, accurate and reliable census data is crucial for the political and economic operation of the United States;
- 4 WHEREAS, the US Census Bureau has announced plans to intentionally introduce hidden inaccuracies into the
- 5 Census as a means of protecting individual privacy;
- 6 WHEREAS, manipulation of census data by the Executive Branch without adequate oversight from the other
- 7 branches of government or the public represents a fundamental risk to democratic, academic, and economic
- 8 institutions in the US;
- 9 THEREFORE, RESOLVED, that the DPW supports legislation requiring the release of raw, unaltered census data for
- 10 noncommercial purposes under conditions that would ensure individual privacy.

#### 21-JHD-26: DEMOCRATS IN CONGRESS MUST CONVENE SELECT COMMITTEES ON 1/6 INSURRECTION (100 WORDS)

- WHEREAS, former President Trump and other Republicans encouraged an insurrection on January 6 to overturn a
- 14 fair election;
- WHEREAS, this insurrection tried to disenfranchise the 1.63 million Wisconsinites that voted for Joe Biden for
- 16 President and Kamala Harris for Vice-President;
- WHEREAS, this insurrection requires a full revelation of facts to carry out justice against these lawbreakers;
- WHEREAS, Republicans are blocking a bipartisan 1/6 Commission because they fear people knowing these facts;
- 19 WHEREAS, Democrats control both houses of Congress;
- THEREFORE, RESOLVED, the DPW urge House Speaker Pelosi and Senate Leader Schumer to convene Select
- 21 Committees to investigate the January 6 insurrection.

# **RESOLUTIONS CONCERNING EDUCATION, LABOR, AND ECONOMICS**

- 24 **21-ELE-01:** Public School Funding (49 words)
- 25 WHEREAS, an informed populace is critical to a well-functioning democracy; and,
- WHEREAS, adequate public funding is vital for quality public schools;
- THEREFORE, RESOLVED, all public funds dedicated to education should be used for developing, maintaining, and
- improving public education; and,
- 29 FINALLY RESOLVED, that the Wisconsin voucher program be abolished.

#### 21-ELE-02: SUPPORT THE PROTECTING THE RIGHT TO ORGANIZE (PRO) ACT (100 WORDS)

- 32 WHEREAS, 65% of Americans approve of labor unions, the highest it has been since the early 2000s;
- 33 WHEREAS, under our current labor law, many employers intimidate and coerce workers, and when they resort to
- 34 illegal tactics such as firing workers for organizing, they incur no monetary penalties;
- WHEREAS, the PRO Act helps restore workers' ability to organize and negotiate for better pay, benefits, and fairness
- on the job; and,
- 37 WHEREAS, the PRO Act promotes greater racial economic justice because unions and collective bargaining brings
- 38 greater fairness to the workplace;
- 39 THEREFORE, RESOLVED, the DPW supports the passage of the PRO Act.

# 41 21-ELE-03: RESOLUTION IN SUPPORT OF A \$15 MINIMUM WAGE, ASAP (90 WORDS)

- WHEREAS, \$15/hour is barely considered a living wage;
- 43 WHEREAS, \$7.25/hour supports a very meager quality of life and impedes the ability to contribute to the economy in
- 44 a meaningful way;
- WHEREAS, higher wages will stimulate the economy through increased consumer spending, and tax revenue;

- 1 WHEREAS, the number of people living in poverty is over 10%, while a \$15/hour minimum wage would decrease
- 2 that number dramatically; and,
- 3 WHEREAS, \$15/hour minimum wage provides a starting point for advancing a living wage standard;
- 4 THEREFORE, RESOLVED, that DPW supports an immediate increase to \$15/hour.

# 21-ELE-04: REPLACING CORPORATE WELFARE WITH ONE FAIR WAGE (99 WORDS)

- WHEREAS, Wisconsin remains a state allowing tipped workers to be paid a sub-minimum, \$2.33 wage;
- 8 WHEREAS, employees paid sub-minimum wages often rely on public assistance, resulting in corporate welfare as
- 9 Wisconsin subsidizes businesses paying less than living wages;
- WHEREAS, employers provided with incentives to pay the full minimum wage plus tips to all of their employees
- would benefit families and taxpayers across the state;
- 12 THEREFORE, RESOLVED, DPW supports legislation to return sales tax on served food and beverages to businesses
- 13 with customarily tipped employees which pay all of their employees at least the prevailing Wisconsin minimum wage
- 14 plus tips.

# 21-ELE-05: RESOLUTION ABOUT CHALLENGES OF DIGITAL DIVIDE AND INADEQUATE BROADBAND INFRASTRUCTURE (97 WORDS)

- WHEREAS, 95% of urban Wisconsin residents and only 63% in rural counties have access to broadband with low-
